Constitution – Items to Review

Honour Committee

1. Currently, the UPS constitution does not have a section under Article 8 describing the Honour Committee since it was established after last year's constitution review.

Be it resolved that the following is added under Article 8, Section 14:

- "a. The Honour Committee shall be comprised of:
 - i. UPS President (Chair)
 - ii. UPS Vice-President
 - iii. UPS Executive Secretary (Secretary)
 - iv. UPS Social Director
 - v. One (1) UPS Athletics Director
 - vi. UPS Staff Advisor
- b. This committee shall promote professional conduct among members of the Society.
- c. The committee shall review incidents of unprofessional behavior and make fair decisions on consequences for the student(s) involved. The Class President(s) for the student(s) involved will hold a temporary position on the Committee for the duration of the investigation. Said consequences are outlined in the UPS Professionalism Policy (Appendix VIII).
- d. Given that a committee member themselves is involved in an incident, they are excused from the committee for the duration of the investigation."

Elections

5. During campaign speeches of both UPS and class council elections, it is strongly encouraged to ask each candidate the same questions in order to allow voters to fairly evaluate candidates. (this is what is done and we want it to be reflected in the constitution

For UPS elections: Be it resolved that the following sentence is added to the UPS constitution under Article 11, Part A, Section 11 of the UPS constitution: "Each candidate running for the same UPS position should be asked the same questions where possible."

For UPS Elections:

1st: Sassha 2nd: Zao Discussion:

- What constitutes "where possible"
 - All questions do not apply to every candidates speech and if the doesn't apply you wouldn't ask it (this is not meant to be an absolute rule but a guideline)
- Can we include that questions must be relevant?
 - o In the past it has been felt that not all questions are relevant but are asked simply to get through the two questions (ex. Do you like Coke?)
 - Questions are usually asked by the person holding the position and the CRO → it is their responsibility to make sure that two relevant questions are asked
 - O Usually open up to the floor first and they use up the two questions before council members get a chance (based on the constitution)
 - o This is also just something that could be mentioned during the speeches → it is felt that it should be more formal in the constitution

Friendly amendment: "each candidate running for the same UPS position should be asked the same position-relevant questions where possible."

7. In the event there is poor voter turnout due to circumstances beyond our control (eg weather, transit strikes, etc), the CRO has the option to postpone an election to ensure there will be an opportunity for enough voters to properly represent the student body.

For UPS elections: Be it resolved that the following sentence is added to Article 11, Part A, Section 19 of the UPS constitution: "On the occurrence where poor voter turnout is suddenly expected due to class cancellation, power outage, transit strike, extreme weather, natural disaster etc, the voting date and times may be changed by the Election Committee with shorter notice than 48 hours provided that voting has not already started."

1st: Sassha 2nd: Stephanie Discussion:

- What constitutes poor voter turnout? → no specific number will be defined but this is just in case a "large proportion" of the class cannot or will not make it
- Should there be a minimum amount of time? → general consensus that this isn't necessary
 - CRO should be responsible enough to make this decision and the whole point is that it is for emergencies which could happen immediately before

Currently, constitution states that if there was a tie in UPS elections between two candidates, and one of them decides to drop out, then it remaining candidate would require a 2/3 majority vote of the student body to be given the position. Instead, it is proposed to treat the remaining candidate as an acclaimed position and require 2/3 majority vote of the outgoing UPS general council."

Be it resolved that Article 11, Part A, Section 23 of the UPS constitution is amended to read "If a candidate decides to drop out, the remaining candidate will be subjected to a 2/3 majority approval vote by the outgoing UPS general council."

- Clarification: is this for all positions
 - o this will not apply to the Pres and $VP \rightarrow$ should we add that?
- There is a separate part of the constitution that applies to "acclamation" of President and VP already so there is no need to reiterate here
- This does not apply to class council elections which is covered in a different section of the constitution

Duties and Roles

10. Under the Events Directors description (Appendix I, Section 7), it states that they have to organize Homecoming Weekend. However, homecoming weekend has not occurred in at least the last two years. Furthermore, this section stated that the U of T Health Fair occurs in mid-February. This is not the case every year (eg this year it was held in Novemeber). Also, Pharmacy Information Night needed to be added to their list of duties.

Be it resolved that Appendix I, Section 7 (e) of the UPS constitution be amended to read: "e. They shall organize:

- i. The U of T Health Fair
- ii. Pharmacy Awareness Week, usually occurring in early March
- iii. Pharmacy Phollies, the annual variety show, usually occurring in the fall
- iv. Pharmacy Information Night, which usually occurs in the fall"

11. Amend the section pertaining to the Monograph in Appendix V (UPS Points System). Currently, Monograph class reps receive 10 UPS points, similar to other class council members. Additionally, the UPS Points and Awards committee have already approved giving a UPS point to each contributor per Monograph. Furthermore, if a contributor has written an article for each edition of the Monograph in a given school year, then he/she will be awarded a bonus UPS point. Be it resolved that the Monograph section under Appendix V of the UPS constitution be amended to read: "At the discretion of the editors for those who submit material or

contribute to the preparation of these publications. Contributors (who are not required per Constitution to submit articles as part of a council position) are awarded 1 point per issue. Furthermore, contributors who have submitted to all 6 issues of the Monograph in a given school year are entitled to one bonus point, for a total of 7 points/year."

Each Fall, the Webmaster shall obtain current lists of enrolled students from the registrar's office and cross-reference this to the listsery. Only registered students are permitted on the UPS listserv."

 - The listsery will randomly kick people off and they need to be added back \rightarrow in this case the webmaster can send to the name to the staff advisor if possible (or Yvonne) for confirmation that the student is enrolled (alternatively, this could also be cross-referenced with the key)
- This discussion does not affect this motion and can be discussed more later

- Would they be required to have a portfolio → this would be determined by the Pharmakon editors (most interviewed positions require a resume and cover letter)
- Do the editors feel that the reps need to have experience to be on the Pharmakon?
 - O Whichever way it goes it won't really affect them
 - o Past editors: may or may be too important that they have technical skills
- Who would select them? → covered in the next motion
- There are merits in making it an interview position but the campaign process
 makes them more visible to the class and then other students may be more
 receptive to having their photo taken, etc.
 - o It is the reps job to make sure that they are taking the pics
 - Students may also not want to send in pics to someone that they do not know
 - O Seems like people don't really seem to know who their yearbook reps are anyway
- This position is meant to be a "representative" and yet the class has no input

- This applies to all interview positions and has been done this way for UPS forever
- o Class council is a little bit different because they represent a smaller group of people
- Can the incoming pharmakon editors assess if the reps would represent their class?
- Can editors approve nominations before the election process?
 - This would be really intensive, not really merited for a class council position
- Solution who may be have the previous class pharmakon rep who can account for whether or not the person is sociable → what would happen for the first year class?
 - o fFr first year it could be elected and then interviewed for 2nd, 3rd and 4th year
- Brought forward in case people are too shy to run → but trying to be elected to represent class so really shouldn't be too shy
 - O Don't have to be the most outgoing person to be at events to take pictures
 - O Very different skill set from getting up and talk in front of people
 - Requires you to put yourself out there which is really hard for some people
